Important Questions	Answers	Why This Matters:
What is the overall deductible?	In-network: \$2,900/Individual; \$5,800/Family. Non-network: \$5,800/Individual; \$11,600/Family. Deductible doesn't apply to in-network preventive care. Copayments don't apply to deductible .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. Preventive services , formulary generic drugs, ER and office visits. Limitations apply.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan?	\$7,000/Individual; \$14,000/Family. No out-of-pocket limit for non-network services.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit?	Premiums , all non-network services, non-network balance-billed charges, and health care services this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

Does this plan provide Minimum Essential Coverage? Yes
