

UCare Connect + Medicare (HMO SNP) 2018 Summary of Benefits

! This is a summary of health services covered by *UCare Connect + Medicare* for 2018. Please read the Evidence of Coverage for the full list of benefits. If you don't have an Evidence of Coverage, call *UCare Connect + Medicare* Customer Services at the number at the bottom of this page to get one.

UCare Connect + Medicare is a health plan that contracts with both Medicare and the Minnesota Medical Assistance (Medicaid) program to provide benefits of both programs to enrollees. Enrollment in *UCare Connect + Medicare* depends on contract renewal.

UCare Connect + Medicare is for people who:

- Are at least 18 years of age and under age 65
- Have a certified disability through Social Security Administration or the State Medical Review Team
- Live in the service area
- Have Medicare Parts A and B and Medical Assistance (Medicaid)

Under *UCare Connect + Medicare* you can get your Medicare and Medical Assistance (Medicaid) services in one health plan. A *UCare Connect + Medicare* care coordinator will help manage your health care needs.

Limitations, copays, and restrictions may apply. For more information, call Customer Services or read the Evidence of Coverage.

The formulary and/or pharmacy and provider networks may change throughout the year. We will send you a notice before we make a change that affects you.

Benefits and/or copays may change on January 1 of each year.

Copays for prescription drugs may vary based on the level of Extra Help you get. Please contact the plan for more details.

Minnesota Department of Human Services (DHS)

You have the right to file a complaint with DHS if you believe you have been discriminated against in our health care programs because of any of the following:

American Indians can continue or begin to use tribal and Indian Health Services (IHS) clinics. We will not require prior approval or impose any conditions for you to get services at these clinics. For enrollees age 65 years and older this includes Elderly Waiver (EW) services accessed through the tribe. If a doctor or other provider in a tribal or IHS clinic refers you to a provider in our network, we will not require you to see your primary care provider prior to the referral.

Complaints must be in writing and filed within 180 days of the date you discovered the alleged discrimination. The complaint must contain your name and address and describe the discrimination you are complaining about. After we get your complaint, we will review it and notify you in writing about whether we have authority to investigate. If we do, we will investigate the complaint.

DHS will notify you in writing of the investigation's outcome. You have a right to appeal the outcome if you disagree with the decision. To appeal, you must send a written request to have DHS review the investigation outcome period. Be brief and state why you disagree with the decision. Include additional information you think is important.

If you file a complaint in this way, the people who work for the agency named in the complaint cannot retaliate against you. This means they cannot punish you in any way for filing a complaint. Filing a complaint in this way does not stop you from seeking out other legal or administration actions.

| What is a Special Needs BasicCare (SNBC) plan? | <p>Our plan is part of the Special Needs BasicCare (SNBC) program. This program was designed by the Minnesota Department of Human Services (DHS) to provide special care for people with disabilities ages 18 through 64. Our plan combines your Medicare and Medical Assistance (Medicaid) services. It combines your doctors, hospital, pharmacies, home health care, nursing home care, and other health care providers into one coordinated care system. It also has care coordinators to help you manage all your providers and services. They all work together to provide the care you need.</p> <p>Our SNBC program is called <i>UCare Connect + Medicare</i>.</p> |
| What is a care coordinator? | <p>A care coordinator is your main contact person. This person helps manage all your providers and services and makes sure you get what you need.</p> |
| Will you get the same Medicare and Medical Assistance (Medicaid) benefits in <i>UCare Connect + Medicare</i> that you get now? | <p>If you are coming to <i>UCare Connect + Medicare</i> from Original Medicare or another Medicare plan, you may get benefits or services differently. You will get almost all of your covered Medicare and Medical Assistance (Medicaid) benefits directly from <i>UCare Connect + Medicare</i>. You will work with a team of providers who will help determine what services will best meet your needs. When you enroll in <i>UCare Connect + Medicare</i>, you and your care team will work together to develop an Individualized Care Plan to address your health and support needs. When you join our plan, if you are taking any Medicare Part D prescription drugs that <i>UCare Connect + Medicare</i> does not normally cover, you can get a temporary supply. We will help you get another drug or get an exception for <i>UCare Connect + Medicare</i> to cover your drug, if medically necessary. For more information, call Customer Services.</p> |

| <p>Can you go to the same health care providers you see now?</p> | <p>That is often the case. If your providers (including doctors and pharmacies) work with <i>UCare Connect + Medicare</i> and have a contract with us, you can keep going to them. Providers with an agreement with us are “in-network.” In most cases, you must use the providers in <i>UCare Connect + Medicare</i>’s network. If you need urgent or emergency care or out-of-area dialysis services, you can use providers outside of <i>UCare Connect + Medicare</i>’s network. You may also use out-of-network providers for open access services and in cases when <i>UCare Connect + Medicare</i> authorizes the use of out-of-network providers.</p> <p>To find out if your providers are in the plan’s network, call Customer Services or read <i>UCare Connect + Medicare</i>’s Provider and Pharmacy Directory. You can also visit our website at ucare.org for the most current listing.</p> <p>If <i>UCare Connect + Medicare</i> is new for you, you can continue seeing the providers you go to now for up to 120 days in certain situations. | <p>What happens if you need a service but no one in <i>UCare Connect + Medicare</i>’s network can provide it?</p> | <p>Most services will be provided by our network providers. If you need a covered service that cannot be provided within our network, <i>UCare Connect + Medicare</i> will pay for the cost of an out-of-network provider.</p> |
| <p>Where is <i>UCare Connect + Medicare</i> available?</p> | <p>The service area for this plan includes the following counties in Minnesota: Anoka, Carver, Dakota, Hennepin, Olmsted, Ramsey, Scott, Sherburne, Stearns, Washington and Wright. You must live in one of these counties to join the plan. Call Customer Services for more information about whether the plan is available where you live.</p> |
| <p>What is service authorization or prior authorization?</p> | <p>Service authorization or prior authorization means that you must get approval from <i>UCare Connect + Medicare</i> before you can get a specific service or drug or see an out-of-network provider. <i>UCare Connect + Medicare</i> may not cover the service or drug if you don’t get approval. If you need urgent or emergency care or out-of-area dialysis services, you don’t need to get approval first.</p> |
| <p>What is a referral?</p> | <p>A referral means getting approval from your primary care provider before you see a specialist. Our plan is a direct access plan. This means you do not need to get a referral or plan approval to see network providers, including specialists.</p> |

| What is Extra Help? | Extra Help is a Medicare program that helps you pay for your prescription drug program costs such as copays. Your prescription drug copays under <i>UCare Connect + Medicare</i> already include the amount of Extra Help you qualify for. | Do you pay a monthly amount (also called a premium) as a member of <i>UCare Connect + Medicare</i> ? | No. Because you have Medical Assistance (Medicaid), you will not pay any monthly premiums for your health coverage. You must continue to pay your Medicare Part B premium unless your Part B premium is paid for you by Medical Assistance (Medicaid) or another third party. |
| Do you pay a deductible as a member of <i>UCare Connect + Medicare</i> ? | No. You do not pay deductibles in <i>UCare Connect + Medicare</i> . |
| What is the maximum out-of-pocket amount that you will pay for medical services as a member of <i>UCare Connect + Medicare</i> ? | There is no cost-sharing for medical services in <i>UCare Connect + Medicare</i> , so your annual out-of-pocket costs will be \$0. |

Your rights as a member of the plan

As a member of *UCare Connect + Medicare*, you have certain rights. You can exercise these rights without being punished. You can also use these rights without losing your health care services. We will tell you about your rights at least once a year. For more information on your rights, please read the Evidence of Coverage. Your rights include, but are not limited to, the following:

- **You have a right to respect, fairness, and dignity.** This includes the right to:
 - Get covered services without concern about medical condition, health status, receipt of health services, claims experience, medical history, disability (including mental impairment), marital status, age, sex (including sex stereotypes and gender identity) sexual orientation, national origin, race, color, religion, creed or public assistance
 - Get information in other formats (for example, large print, braille, or audio) free of charge
 - Be free from any form of physical restraint or seclusion
- **You have the right to get information about your health care.** This includes information on treatment and your treatment options. This information should be in a format you can understand. This includes the right to get information on:
 - Description of the services we cover
 - How to get services
 - How much services will cost you
 - Names of health care providers
- **You have the right to make decisions about your care, including refusing treatment.** This includes the right to:
 - Choose a primary care provider (PCP). You can change your PCP at any time.
 - See a women’s health care provider without a referral
 - Get your covered services and drugs quickly
 - Know about all treatment options, no matter what they cost or whether they are covered
 - Refuse treatment, even if your health care provider advises against it
 - Stop taking medicine, even if your health care provider advises against it
 - Ask for a second opinion. *UCare Connect + Medicare* will pay for the cost of your second opinion visit.

- **You have the right to make complaints about your covered services or care.** This includes the right to:
 - File a complaint or grievance against us or our providers
 - Ask for a state fair hearing
 - Get a detailed reason for why services were denied
