What is the overall <a href="#">deductible</a> ?	In-network: \$5,900/Individual; \$11,800/Family. Non-network: \$11,800/Individual; \$23,600/Family.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the plan, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive services</a> and office visits. Formulary drugs, except non-preferred brand and specialty. Limitations apply. <a href="#">Copayments</a> don't apply to <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	\$8,550/Individual; \$17,100/Family. No <a href="#">out-of-pocket limit</a> for non-network services.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. If you have other family members in this <a href="#">plan</a> , they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket limit</a> has been met.
What is not included in the <a href="#">out-of-pocket limit</a> ?	<a href="#">Premiums</a> , all non-network services, non-network balance-billed charges, and health care services this <a href="#">plan</a> doesn't cover.
