What is the overall <a href="#">deductible</a> ?	In-network: \$100/Individual; \$200/Family. Non-network: \$200/Individual; \$400/Family.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the plan, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive services</a> , ER and office visits. Formulary drugs except non-preferred brand and specialty. Limitations apply. <a href="#">Copayments</a> don't apply to <a href="#">deductible</a> . The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. - Hearing aids—unless age 18 or younger and requirements are met

- Intensive behavioral therapy for treatment of autism spectrum disorders
- Long-term care
- Non-emergency care when traveling outside U.S.
- Non-formulary drugs unless an exception is obtained
- Private-duty nursing—except up to 120 hours is covered to train hospital staff for a ventilator-dependent patient
- Routine dental care for adults
- Routine eye care (Adult)
- Routine foot care
- Weight loss programs
